COMPLETION OF MAJOR TRANSACTION DISPOSAL OF MINORITY INTEREST IN YOPLAIT CHINA

References are made to the announcements dated December 1, 2025 of Tian Tu Capital Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) and the circular of the Company dated January 14, 2026 (the “**Circular**”) in relation to the Disposal of the Group’s minority interest in Yoplait China and the announcement of the Company dated February 2, 2026 in relation to the poll results of the extraordinary general meeting of the Company. Unless otherwise defined, capitalized terms used herein shall have the same meanings as defined in the Circular.

As disclosed in the announcement of the Company dated December 1, 2025, the Group and the Group’s associates measured using equity method entered into the Share Purchase Agreement with the Purchaser, pursuant to which, inter alia, the Group and the Group’s associates measured using equity method agreed to sell and the Purchaser agreed to acquire approximately 86.96% of the equity interest in Yoplait China. The aggregate consideration amounts to RMB1,565,217,391.

The Company is pleased to announce that Completion had taken place in accordance with the terms and conditions of the Share Purchase Agreement.

Following Completion, the Company ceased to have any equity interest in Yoplait China. Accordingly, Yoplait China ceased to be classified as interests in associates measured at fair value in the Group's consolidated financial statements.
